


Sir,

In continuation to this Ministry's letter of intent of even number dated 6.7.2007 and with reference to your letter No 1764-1765/E.I./07 dated 11.7.2007, I am directed to convey the approval of the Central Government for the increase of seats in MBBS from 50 to 100 at Sri Guru Ram Das Institute of Medical Sciences & Research Centre, Sri Amritsar with prospective effect i.e. from the academic year 2007-08 under Section 10(A) of IMC Act, 1956, as amended.

2. This permission of the Central Government for increase of seats and admission of students against the increased intake is initially for a period of one year subject to renewal on annual basis on achievement of annual targets set out in the project report and verification thereto by the Medical Council of India. The College shall not admit more than one batch of students against this letter of permission on the increased intake. The college shall also apply to Medical Council of India for renewal of permission against the increased intake well before the commencement of next academic session. While applying for such renewal, the achievement in terms of infrastructure, staff and equipment as spelt out in the time bound action plan and as required by Medical Council of India norms must be clearly indicated. The next batch of students against the increased intake shall not be admitted unless renewal of permission is granted by the Central Government.



The permission is, however, subject to the condition that the bank guarantee of Rs. 1.00 crore furnished by the institute authorities against the increased intake is found to be in order in all respect. The admission process for the academic year 2007-08 has to be completed in accordance with the time schedule indicated in the Graduate Medical Education Regulation, 1997, as amended.
