Sir,

I am directed to say that your college was assessed by the Assessors appointed by MARB to conduct virual assessment during the final MBBS practical Examination from 21.03.2022 to 24.03.2022. The report of physical assessment is not available with UGMEB. However, as per the decision taken in the Commission in its meeting held on 11.04.2023, in case infrastructural assessment as well as examination assessment have been carried out, the application for Recognition should be processed as per the regulation norms. In case only one assessment has been carried out, recognition is to be processed for **only one year** henceforth.

2. Accordingly, your college was considered for grant of Continuation of Recognition (only for one year) of MBBS degree (150 seats), awarded by Sri Guru Ram Das University of Health Sciences, Amritsar, Punjab. While evaluating the assessment reports alongwith the AEBAS and HMIS data including CCTV, the following deficiencies have been observed:

A. Deficiency in Faculty and Residnts as observed on AEBAS record data:

The faculty and Senior resident doctor deficiency is calculated on the basis of attendance of registered persons by the college on AEBAS records. The attendance of these faculty is ranging from zero to less than 50% of the total working days. Out of 267 persons registered, 38 have zero attendance and 32 have less than 50% attendance.

3. After careful consideration, it has been decided in Undergraduate Medical Education Board (UGMEB) that Continuation of Recognition may be granted to the MBBS degree awarded bySri Guru Ram Das University of Health Sciences, Amritsar, Punjab to 150 students of Sri Guru Ram Das Medical Sciences & Research, Amritsar, Punjab with directions to the college authorities to fulfill all the requirement as per prevalent rules and regulations.

- 4. Accordingly, the approval of the competent authority in UGMEB is hereby conveyed for grant of **Continuation of Recognition for ONE YEAR** of MBBS degree for 150 students awarded by Sri Guru Ram Das University of Health Sciences, Amritsar, Punjab in respect of the students being trained at Sri Guru Ram Das Medical Sciences & Research, Amritsar, Punjab.
- 5. You are also directed to fulfill all the deficiencies mentioned above and advised to apply afresh to UGMEB in 2024 for grant of Continuation of Recognition for 150 MBBS seats, at least six (6) months prior to the final examination of MBBS Part-II (Practical) alongwith the requisite fee i.e. Rs.3.54 lakhs only.
- 7. This issues with the approval of President, UGMEB.
