Whereas AECS (P) LTD. has setup a (CBWTF) Common Bio Medical Waste Treatment Facility at Chabal Road, Village Iban- Kalan, Amritsar and has obtained the authorization from Punjab Pollution Control Board, (PPCB) Patiala to operate this facility for collection, transportation, treatment and disposal of Bio- Medical Wastes (hereinafter called as BMW) generated by the Health Care Establishments (HCEs), Hospitals, Nursing Homes, Blood Banks, OPD Clinics, Pathological Laboratories, Diagnostic Centers etc.)

Whereas AECS (P) LTD. offers to provide service to the GENERATOR on a user Pay Principal for Collection, Transportation, Treatment, and Disposal of BMW at the rates as being multually agreed upon by both the parties along with other terms and conditions will deposit to the generator the security equivalent to the one month payment to be made to AECS (P) Ltd. which will be refundable without interest after satisfactory completion of the agreement.

 agreement terms and conditions.
- 3. AECS (P) Ltd. shall collect daily BMW from the GENERATOR premises.
- 4. In case AECS (P) LTD. vehicle fails to collect the BMW within 24 hours of the designated time (24 hours) due to any reason, the GENERATOR shall inform the AECS (P) LTD. office at Amritsar, who will ensure to strictly collect the BMW within the next 24 hours. AECS (P) LTD. shall be solely responsible for the consequences, if any, in this regard. AECS (P) LTD. office shall maintain a

- Complaints, if any made to AECS (P) Ltd., Amritsar at Phone No / Mobile No. 9653470000 office by the GENERATOR. AECS (P) LTD., promises to attend to all such complaints, within the shortest possible time. The company will give complaint no for every complaint lodged.
- AECS (P) LTD. shall collect the segregated bio-medical waste from the identified common waste collection site in the premises of GENERATOR.
- 7. AECS (P) LTD. shall provide an assistance to finalize the pickup location to the GENERATOR.
- AECS (P) LTD. shall transport the segregated waste in closed container vehicle to its treatment plant.
- If the GENERATOR desires, the initial training about segregation of BMW in colour coded Plastic bags and method of collection of BMW, the same shall be provided by AECS (P) LTD, at no extra cost.
- 10. AECS (P) LTD. shall schedule the timings for collecting the waste in consultation with the GENERATOR.
- 11. AECS (P) LTD. promises to keep high standard of pollution control and shall update its equipment / facility as and when required.
- 12. AECS (P) LTD. Will not be liable for Environment. (Protection) Act 1986 or any similar regulations/ norms set up by PPCB, Government Bodies, in the event the GENERATOR violates any of the terms and conditions.
- 13. AECS (P) LTD. shall be responsible for appropriate treatment and shredding of disinfected waste at the centralized facility as per Schedule-1 of the Bio Medical Waste Management Rules 2016.
- 14. AECS (P) LTD. shall also undertake testing of treated waste to ensure safety to the environment.
- 15. AECS (P) LTD. shall also be responsible for the disposal of treated waste into secured landfills or in recycling plants as applicable.
- 16. AECS (P) LTD shall provide a copy new rules or any amendment made by PPCB in relation to Bio Medical waste Management Rules 2016 from time to time.

RESPONSIBILITIES OF THE GENERATOR

- 1. The GENERATOR shall segregate the waste at the point of generation in accordance with the Bio Medical Waste Management Rules 2016 and in compliance with the standards prescribed there under.
- 2. The GENERATOR shall collect the segregated BMW in Polyethylene (Non Chlorinated) bags as stipulated by Punjab Pollution Control Board (PPCB) norms.
- 3. All consumables like bags, needle cutters, disinfectants etc. shall be procured by the GENERATOR at its own cost. AECS (P) LTD. is committed to supply the same at reasonable rates.
- 4. The bags used for collecting soiled materials, placenta, amputated body parts etc., (required to be incinerated) shall be non-chlorinated plastic bags.
- 5. All the bags shall be sealed tightly by the GENERATOR and AECS (P) LTD. will collect the sealed bags only at a secured designated point in the premises of the GENERATOR.
- 6. The GENERATOR shall disinfect the sharp and mutilate them and hand them over in Puncture Proof Containers to AECS (P) LTD.

The Generator shall inform AECS (P) LTD. about any such change in the number of beds. The total no. of beds for which agreement stands for is 765.

TERMS OF MEMBERSHIP & PAYMENT

- 1. The security advance of 1 month taken from the AECS (P) Ltd is refundable without interest after the completion of this agreement.
